



AGREEMENT OF COLLABORATION BETWEEN PABLO DE
OLAVIDE UNIVERSITY, OF SEVILLE, SPAIN, AND
MOHAMMED I UNIVERSITY OF OUJDA, MOROCCO.

30 January 2017

The University Pablo de Olavide of Seville, Spain, represented by its authorized representative, Mr. Vicente C. Guzman Fluja, Rector Magnificus.

AND

Mohammed I University of Oujda, Morocco, represented by its authorized representative, Mr. Mohammed BenKaddour, President of the University

Hereby agree

to sign a General Protocol of Collaboration with the intention of establishing an adequate institutional and legal framework in order to promote common researches, seminars, academic exchanges, and all others activities related to research and education.

With this aim, the two universities (hereafter referred to as the Parties) sign the present General Protocol according to the following terms:

FIRST- The University Pablo de Olavide of Seville and Mohammed I University of Oujda will promote collaboration with the intention of developing common research projects, seminars, academic exchanges and activities linked to research and education.

SECOND- The Parties will exchange the necessary information for the determination of specific work areas in view of developing combined projects.

THIRD- The present General Protocol will be developed by means of specific agreements which will be signed by the Parties, after they have been ratified by those representatives that both parts will appoint with this aim.

FOURTH.- In order to arrange these relationships, a Steering Committee is created with two representatives, one of them appointed by the University Pablo de Olavide and the other appointed by the University of Oujda.

FIFTH.- This Agreement shall be effective as of the date above written and continue in full force and effect until terminated by the Parties. Official review of the Agreement shall take place every two (2) years after the initial implementation of the Agreement.



SIXTH.- In the event of any conflict concerning the interpretation of the clauses of this Protocol, or their performance hereunder, both Parties hereby agree to submit the said dispute to an Arbitration Committee formed by two members appointed by each Party and a third one appointed in mutual agreement; and in his/her absence, this one will be chosen at random out of a cast of people appointed by both Parties in equal numbers.

SEVENTH.- The effectiveness of this Protocol is subject to its ratification by the Governing Board of Pablo de Olavide University of Seville.


EIGHTH.- The effectiveness of this Protocol is subject to its ratification by the Governing Board of Mohammed I University of Oujda.
